Government Contracts

Types of clients. Among our clients are companies providing a wide range of goods and services to the government including in the areas of aerospace and defense, information technologies, nuclear and alternative energy, construction, environmental protection and remediation, and disaster recovery.

Procurement. We represent government contractors in virtually every phase of the procurement process, including submission of bids, negotiation of proposals and subcontracts, bid protests, joint ventures and teaming agreements, financing, cost and pricing data questions, and contract performance and claims resolution. We advocate in litigation matters on behalf of government contractors in state and federal courts, and assist with avoidance of suspension and debarment for ethical and contract integrity concerns.

Small business contracting. Lawyers on our team provide counsel on set-asides and preferences for small and disadvantaged businesses, as well as veteran-owned and HUBZone contractors.

Employment and prevailing wage requirements. We advise on employment matters unique to government contractors including affirmative action plans and compliance with minimum and prevailing wage requirements. We also represent and defend clients facing audits by the U.S. Department of Labor and compliance reviews brought by the Office of Federal Contract Compliance Programs (OFCCP) related to the Service Contract Act and Davis-Bacon Act issues

Sourcing compliance. Our team provides counsel on laws and regulations governing the sourcing of materials used in government contracts including the U.S. General Services Administration Federal Supply Schedule, the Buy American Act and Trade Agreements Act.

Mergers and acquisitions. We advise on the full range of legal issues which arise when government contractors engage in mergers and acquisitions.

Investigations and dispute resolution. The attorneys on our team counsel clients regarding civil and criminal investigations and internal investigations associated with government contracts, performance and termination disputes arising from prime contracts and subcontracts, and claims brought by the federal government under the False Claims Act. We have litigated claims in state and federal courts, including the U.S. Court of Federal Claims and various Boards of Contract Appeals.

Public policy and government relations. When the law or regulations governing government contracts are unclear or need to be changed, our public policy advisors have solid and longstanding relationships with government decision makers.
