#### No Match - Rule Rescinded to No Man's Land

- Before 2007: Informal INS/DHS Don't ignore no-match. Tyson indicated, Walmart fined
- Proposed "Safe Harbor Rule": specific steps for SSA/DHS no-match
- Rule retracted: back to future Don't ignore what you learn
- Steps to handle no-match
- Employment verification policy
- Corporate compliance program



## E-Verify: Voluntary, or Required of Private, State and Federal Contractors

- E-Verify: what it has become, how it works
- State options: nothing, contractors, grantees, business licenses
- Federal contractors: contracts with "E-Verify clause." Recent blanket move.
- Private purchasers: requiring E-Verify of vendors. Walmart options.
- Voluntary: clarity vs. hassle
- How to confirm E-Verify participation



### **ICE Audits Thousands of Employers**

- History: training, inaction, prosecution, back to fines
- Focus on "critical infrastructure" where could a terrorist cause harm?
- Tips and suspicions, random
- Notice to inspect, admin. subpoena for documents
- Self-audits, fixes, communication with ICE



# Prospects for "Comprehensive Reform" (including legalization)

- Hispanic caucus: small fixes hostage to whole enchilada
- Legalization of those here vs. future flow
- Enforcement first
- McCain-Kennedy essence will return (see summary at our site)



### **Restrictions on H-1B via Staffing Vendors**

- Situation: staffing vendor uses H or L, places at your co.
- Pushback: politics, technicalities, politics
- Risk: sudden disappearance of key staffed workers



 Option: direct hires, prepare alternative staffing plan

### **Employers Sponsoring Workers ...**

- New visa forms and fees by State Department
- On-Site visits by USCIS
- Longer waits for visa numbers
- PERM audits and delays
- OFAC and deemed exports



### **Employers Sponsoring Workers**

- Tax reporting of foreign holdings
- Driver's license complications
- Savings clauses for family of deceased
- Transportation and visa costs for H-2 workers
- Correcting erroneous I-94s
