Charles K. Grant is a veteran litigator who has tried more than 50 jury trials to verdict in both federal and state courts, and represented numerous clients in mediation and arbitration proceedings across more than a dozen states.

Mr. Grant represents clients in complex employment litigation, including collective actions under the Fair Labor Standards Act, business litigation, whistleblower actions under federal and state law, as well as matters under 42 U.S.C. § 1983. He is a shareholder in the Firm's Nashville office and a former member of the Firm's Board of Directors. Mr. Grant's clients also include licensed professionals, such as lawyers, physicians and dentists, whom he has represented before licensing boards.

Representative Trials

- Successfully defended Fortune 10 company in state court jury trial against claims brought under the Age Discrimination in Employment Act and the Tennessee Human Rights Act, and against claims alleging negligent infliction of emotional distress and intentional infliction of emotional distress. Plaintiffs sought damages of \$60 million.
- Obtained defense verdict in state court jury trial on claim of retaliatory discharge for asserting workers' compensation claim.
- Served as co-trial counsel representing landowner in \$30 million jury verdict in eminent domain case. Successfully defended verdict in Tennessee Court of Appeals.
- Obtained defense verdict in federal court jury trial on claims of discrimination, failure to engage in interactive process, and retaliation under the Americans with Disabilities Act.

Representative Matters

- Defended prisoner transportation company in numerous § 1983 actions in more than a dozen states.
