Mr. Woolf also represents clients in a wide variety of commercial litigation matters, with particular experience representing both plaintiffs and defendants in securities fraud litigation, complex corporate class and mass action litigation, and a variety of contractual, fiduciary and business tort litigation.

### Representative Matters
