Scott D. Carey concentrates his practice in complex business and tort litigation, with a special emphasis on logistics and transportation-related litigation. He is the former leader of the Transportation Group and is the former managing shareholder of Baker Donelson's Nashville office.

Mr. Carey is a seasoned litigator who represents clients across the United States and internationally in high exposure litigation. He is licensed in both Tennessee and Georgia and is a certified Rule 31 Mediator.

Mr. Carey defends motor carriers, logistics brokers, and shippers in serious tractor trailer accidents, as well as a wide range of clients in other industries in catastrophic injury cases. He routinely advises clients on the Federal Motor Carrier Safety Regulations, and he is a member of the Firm's 24-Hour Emergency Response Team.

He represents transportation brokers, freight forwarders, warehouseman, other third-party logistics providers and shippers in a broad range of disputes, including breaches of transportation and logistics contracts; enforcement of non-compete agreements; high value cargo damage and loss claims under the Carmack Amendment; freight charge and rate controversies; insurance coverage disputes; and class action defense. Mr. Carey reviews, drafts, and negotiates all types of logistics and transportation agreements and counsels his clients on identifying and mitigating risks.

Mr. Carey also has significant experience representing a leading provider of funeral, cremation, and cemetery services. For more than 30 years, he has defended the industry in state and federal courts against a variety of suits and class actions including claims for infliction of emotional distress, outrageous conduct, tortious interference, breach of fiduciary duty, gross negligence, violation of the Telephone Consumer Protection Act, breach of contract, consumer protection violations, premises liability, and punitive damages, among others. He has also represented funeral homes and cemeteries before state regulatory agencies and boards.

In addition to his 30 plus years of litigation experience, Mr. Carey also represents major manufacturing companies in their economic development incentive matters. He has served as the legal project manager for several of the largest foreign direct investments in Tennessee history. He is a member of the Firm's Electric Vehicle and Infrastructure Team (EVI), which supports EV manufacturers and suppliers, including software technology and charging system providers, in all legal and business matters.
