His practice focuses on the preparation and defense of claims involving bid protests, payment disputes, project delays and disruptions, wrongful termination, construction, engineering and design defects, and related matters. Mr. Schollaert has also represented owners, public agencies, contractors, and subcontractors in bond default matters providing advice and assistance to ensure the completion of the projects and the resolution of claims. He has represented both developers and contractors on numerous power and energy projects, including utility-scale solar, wind, and coal power projects.

Mr. Schollaert has also been named in *Maryland Super Lawyers* since 2009 and listed in *The Best Lawyers in America*®, Construction Law category from 2014 – 2026. Representative Matters

- Represented a modular contractor in the defense of delays and construction defects claims for a public school project. After five days of virtual arbitration hearings, the Panel rejected the claims asserted against the contractor and awarded almost the entirety of the contractor's affirmative claims.

- Drafted master design and construction management agreements for the construction and fit-out of pharmaceutical manufacturing facilities and subsequently negotiated those agreements with designers and construction managers on specific construction projects throughout the United States.
- Acted as lead counsel in a multi-week jury trial defending an international engineering firm from design-defect and delay claims brought by a municipality alleging more than \$65 million in compensatory and punitive damages.
- Filed a bid protest with the U.S. Government Accountability Office (GAO) on behalf of contractor that was excluded from the competitive range for a \$48 million construction procurement. In response to various arguments related to evaluation errors, the agency took corrective action and agreed to reevaluate the client's proposal in full and to create a new competitive range.
- Represented the construction manager in resolving various claims and disputes arising out of the construction of one of the largest hotel and convention center complexes on the eastern seaboard with a total project cost in excess of \$800 million.
- Obtained a defense verdict for a pre-cast subcontractor sued under the theory of promissory estoppel after withdrawing its bid on a parking garage project.
- Filed bid protest and appeal with the Maryland State Board of Contract Appeals (MSBCA) over an agency's decision to reject all bids and cancel a procurement concerning the rehabilitation of multiple bridges. After fully briefing the matter before the MSBCA, the agency agreed to settle and award the construction contract to our client, the low bidder for the original procurement.
- Represented the general contractor in delay and inefficiency claims arising out of the construction of a 1.6 MW wind farm. After more than four weeks of arbitration and post-arbitration proceedings, the general contractor was awarded nearly the entirety of its claim along with interest and attorneys' fees.
- Negotiated a favorable settlement agreement with a state agency on behalf of a landowner to ensure continuous monitoring and improvement of a lake and its tributaries that were contaminated by adjacent construction activities.
- Represented a subcontractor in an arbitration against a general contractor arising from the construction and renovation of an elementary school. The arbitrator awarded the subcontractor the vast majority of its claims and denied all back charges to the general contractor.
- Represented an electrical subcontractor in claims arising out of the largest solar project in the state of Maryland.
- Advised the developer regarding EPC contracting issues and negotiated the resolution of delay and claims arising out of four separate solar projects exceeding 51MW.
- Represented a subcontractor in a lawsuit against the prime contractor for failure to pay for sprinkler work performed on a building project. Following trial, secured a judgment for all of the claimed damages, as well as interest and attorneys' fees upon a showing that the prime contractor knowingly and in bad faith refused to pay.
- Drafted and negotiated a contract on behalf of a health care system for the construction of a new medical building with a guaranteed maximum price (GMP) of \$95 million. Drafted and negotiated a contract for the construction of a central utility plant associated with the medical building with a GMP of \$24 million.
