His 30-plus years in private practice enable him to serve as a mediator and arbitrator in complex commercial disputes, multi-party personal injury cases, first-party insurance claims and employment lawsuits.

Mr. Sharp has tried oil and gas lease disputes, environmental pollution cases, business interruption claims, fiduciary duty claims, pipeline construction cases, employment discrimination and retaliation cases, and a variety of industrial and occupational injury lawsuits, including wrongful death and survival cases. Mr. Sharp has represented exploration and production companies, midstream pipelines, oilfield service companies, refineries and forest products manufacturers.

Mr. Sharp conducts internal investigations for public school districts in Texas.
