## Gaming

Domestic and international businesses and individuals seeking gaming licenses and related approvals rely on us, as well as those who already hold such licenses and/or approvals. For example:

- For those seeking to develop a new casino, our team can assist them in structuring and forming an entity to hold the gaming operator license; in securing a proposed casino site; in obtaining all regulatory approvals required to build and operate a casino on that site and in securing project financing.
- For casino developers and manufacturers and distributors of gaming devices and associated gaming equipment, team members can inform them of all licensing and related approval requirements and also shepherd them and their affiliates (e.g., holding companies, equity owners, management and employees), through all stages of the application and investigation processes to receive a gaming license, holding company registration, finding of suitability, key employee license or work permit.
- For persons already holding gaming licenses or other gaming approvals, we can provide a number of services. Team members can advise them regarding the structure of proposed financing and equity transactions (e.g. private placements, public offerings and extensions of credit) so as to minimize gaming issues and assist them in obtaining any regulatory approvals required in connection with those transactions. We can aid in their efforts to obtain gaming device, system and equipment approvals. We can represent them in disciplinary matters before gaming regulators and in casino patron disputes. Our team can apprise them of, and analyze for them, pending legislation that could potentially affect the gaming industry. We can aid them in drafting and implementing compliance plans. Our attorneys can also provide guidance and representation to gaming licensees and their affiliates regarding real estate matters, contract disputes, labor and employment issues, construction disputes, collection matters, financings, tort and insurance matters, securities transactions, tax matters, marketing and advertising issues and general commercial matters.
