Kenneth M. Klemm to be Featured Speaker at National Energy Law Conference

A number of cases instituted by mineral interest owners sought enforcement of agreed-upon bonus payments and other lease terms even though offers were rescinded during title examination periods or prior to the mineral interest owners executing valid leases. This has become an area of significant concern for operators."

A graduate of the Fordham University School of Law, Mr. Klemm is an experienced litigator who primarily defends clients in marine, energy, oil and gas litigation. His clients range from local businesses and individuals and oil and pollution clean-up companies, to the world's largest independent natural gas producer, one of the world's largest oil field services companies, regional and national transporters of natural gas, and national insurance companies. Mr. Klemm is a frequent speaker on litigation-related topics involving admiralty and maritime issues, environmental law and oil and gas casualties.
